

We are pleased to present this year's Annual Water Quality Report. This report is designed to inform you about the water quality and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. Our water comes from wells that draw groundwater from the Pine River alluvium. Some people may be more vulnerable to contaminants in drinking water than the public in general.

All drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV-AIDS or other immune system disorders, some elderly and infants can be particularly at risk of infections. More information about contaminants and potential health effects, or to receive a copy of the U.S. Environmental Protection Agency (EPA) and the U.S. Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by cryptosporidium and microbiological contaminants call the EPA Safe Drinking Water Hotline at 1-800-426-4791.

The sources of drinking water both tap water and bottled water; include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- **Microbial** contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- **Inorganic** contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

- **Pesticides and herbicides**, that may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- **Organic** chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production and also may come from gas stations, urban storm water runoff and septic systems.
- **Radioactive** contaminants, that can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the Colorado Department of Health and Environment prescribes regulations limiting the amount of certain contaminants in water provided by public water systems. The U.S. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

The table contains many terms and abbreviations that may be unfamiliar. To help you better understand these terms we have provided the following definitions:

AL	Action Level – the concentration of a contaminant that, if exceeded, triggers treatment or other requirements a water system must follow.
HS	High Solids – alpha was not tested
MCL	Maximum Contaminant Level - The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	Maximum Contaminant Level Goal - The "Goal" is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MRDLG	Maximum Residual Disinfectant Level Goal- The level of a drinking water disinfectant, below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
MRDL	Maximum Residual Disinfectant Level – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
MFL	Million fibers per Liter – A measure of the presence of asbestos fibers in water longer than 10 micrometers.
mrem/year	Millirems per Year – A measure of radiation absorbed by the body.
NTU	Nephelometric Turbidity Unit – is a measure of the clarity of water. Turbidity in excess of five NTU is just noticeable to the average person.
NA	Not Applicable
ND or BDL	Non-Detects or Below Detection Level- laboratory analysis indicates that the contaminant is not present ("<" symbol for less than, the same as ND or BDL)
NT	Not tested.
ppm or mg/l	Parts per million or Milligrams per liter (mg/l). One part per million corresponds to one minute in two years or one penny in \$10,000.
ppb or ug/l	Parts per billion or Micrograms per liter (ug/l). One part per billion corresponds to one minute in 2,000 years, or one penny in \$10,000,000.
ppt or ng/l	Parts per trillion or Nanograms per liter (ng/l). One part per trillion corresponds to one minute in 2,000,000 years or one penny in \$10,000,000,000.
ppq or pg/l	Parts per quadrillion or Picograms per liter (pg/l). One part per quadrillion corresponds to one minute in 2,000,000,000 years or one penny in \$10,000,000,000,000.
pCi/l	PicoCuries per liter – a measure of radioactivity in water.
TT	Treatment Technique – is a required process intended to reduce the level of a contaminant in drinking water.
	Variations and Exemptions – State permission not to meet an MCL or a treatment technique under certain conditions.

Microbiological Contaminants

We are required to add a disinfectant to the water to protect you against microbial contaminants. Beginning on July 6, 2004 water samples found total coliform bacteria present which is an indicator organism, but additional tests for fecal coliform and E.coli were found to be absent. The same sampling point subsequently tested absent for total coliform bacteria on July 13, 2004 and a non-emergency public notification was issued on July 26, 2004 in accordance with the CO Primary Drinking Water Regulations. Satisfactory disinfectant levels were indicated during samplings and additional testing upstream and downstream of the sample point were reported absent. The cause was traced to temperature stratification in the Pine Ridge water storage tank and recent fire hydrant flushing and testing. The tank disinfectant level was boosted directly in the tank, the upper water zone of the tank was purged and area water lines were flushed with additional testing at sites above and below the tank reported absent of total coliform bacteria. In addition, operational changes were made to prevent future incidents from occurring. Bacteria of greater concern such as fecal coliform and E. coli were not present in any of the samples.

The Forest Lakes Metro District is pleased to report that the District experienced **NO OTHER VIOLATIONS** of an MCL, Treatment Technique or Monitoring and Reporting requirement further reducing your potential for an adverse health effect from drinking our water.

Forest Lakes routinely monitors for constituents in your drinking water according to Federal and State laws. The following table shows the results of our water quality analysis. **All regulated contaminants that were detected in the water, even in minute traces, are listed here.** The table contains the name of each substance, test date, unit of measurement, the highest level allowed by regulation (MCL), the ideal goals for public health (MCLG), the amount detected, the usual sources of such contamination and if the level detected is in violation. This table shows the results of our monitoring for the period of January 1 to December 31, 2004, unless otherwise noted.

The State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. Some of our data, though representative, may be more than one year old.

Radon is currently not regulated but the District voluntarily participated in the Colorado radon water survey in 1998, which reported a radon level in our water of 1135 pCi/l (picocuries per liter). Testing of other unregulated contaminants on 4/1/03 produced the following results: sodium = 5.2 ppm, nickel = < 3 ppt. In addition, the State has issued our water system waivers from monitoring for asbestos, cyanide, glyphosate, and nitrite. There is a Colorado statewide waiver for dioxin monitoring.

The State recently completed source water assessments for most community water systems. The District has received this assessment, which can be viewed at the District offices.
